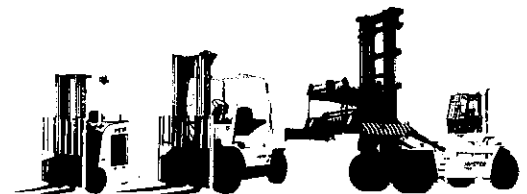
The Dealer Managed National Account Agreement will expire in three (3) years from the date of this agreement which will be December 19, 2010.
