The Dealer Managed National Account Agreement will expire in three (3) years from the date of this agreement which will be March 25, 2012.

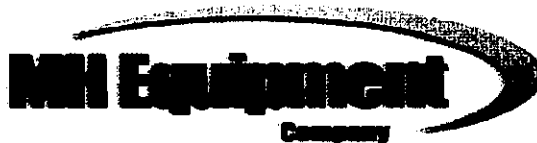

The Dealer Managed National Account program is structured as follows:

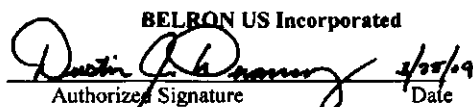
