The Dealer Managed National Account Agreement will expire in three (3) years from the date of this agreement which will be March 7, 2010.

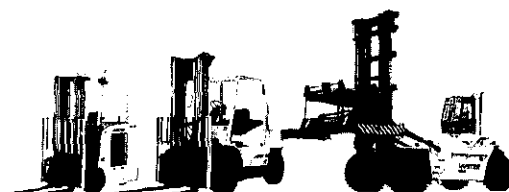
