Notice shall be considered given when made in writing personally or by certified mail deposited in the U.S. mail, postage prepaid to the other party at the address of such party indicated in this agreement or such other address notified by one party to the other.

SCOPE: The discount in this Agreement applies only to equipment ordered in the United States for delivery in the United States.

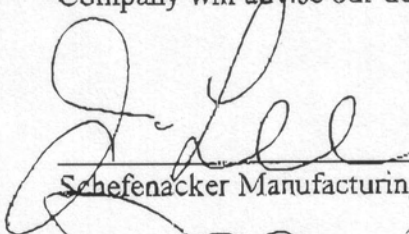

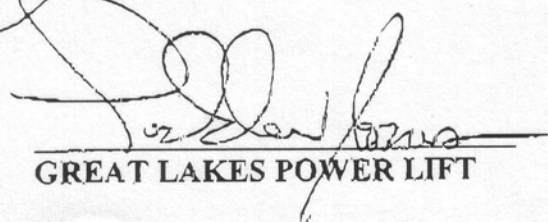
