AGREEMENT:

This Agreement covers a term of one year beginning January 1, 2002 and will expire on January 1, 2003.

This Agreement shall be in effect for one year from its date and shall continue thereafter until either party notifies the other in writing of its intent to terminate, which notice shall state an effective date of termination that is not less than thirty days after the giving of notice. No truck orders may be placed with Great Lakes Power Lift Inc., under the terms of this agreement after the date notice of termination is given by either party, but any truck on order prior to the giving of such notice shall remain on order and the order shall be filled in accordance with this agreement even though delivery or other performance by either party may not occur until after the effective date of termination. Notice shall be considered given when made in writing personally or by certified mail deposited in the U.S. mail, postage prepaid to the other party at the address of such party indicated in this agreement or such other address notified by one party to the other.

SCOPE: The discount in this Agreement applies only to equipment ordered in the United States for delivery in the United States.

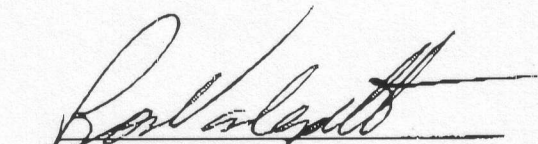

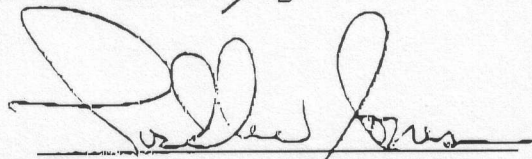
