Heavy Duty Applications - Agricultural, automotive, bottling, building supply, concrete/brick yard, lumber, mining, plastics, railroading, rough terrain, sand, stevedoring, stone, glass, clay, textile, wet or humid environments.

Cooler/Refrigerated Applications - Defined as temperatures above 32 degrees F (in or outside) or units operating 100% of the time in a freezer.

Freezer Applications - Temperature below 32 degrees F. Units used 100% of the time in a freezer.

Severe Applications - In & out of a freezer application, abrasive manufacturing, acid, alkali, brine and pickling, chemical plants, corrosives, excessive heat, fertilizer plants, forging, foundries, heavy manufacturing, high dust and lint environments, metal working, metal shavings, rubber, poultry processing, fish processing, refractory, salt water environments, steel mills, tanneries and hides, recycling.

Rates will be protected for delivery up to 90 days from date of credit approval. A one time documentation fee of \$195 will apply to all new Lease Agreements.
